Arena groups square off

Spirited discussion expected, four days before Dallas election

Jan. 13, just four days before Dallas voters decide whether to spend \$125 million in higher car rental and hotel-motel taxes to help build a downtown arena for the Mavericks and Stars, Fort Worth SPJ will host a panel on the subject, which promises to be lively.

"Those people who believe the teams will stay in Dallas [if voters reject the funding plan] are simply dreaming," said state Sen. John Carona, treasurer of Yes! Let's Build It.

Let 'em dream, says Sharon Boyd, treasurer of It's a Bad Deal! "The arrogance of these people is just off the charts. They have such contempt for Dallas voters," she said. "This is not about keeping the teams in Dallas. It's always been a giant real estate deal. It was just a question of which giants were going to get the deal."

Long-time Dallas radio newsman Rick Eric-

son will represent the pro-arena forces at the meeting and Boyd the anti-arena side. Dr. Charles Davis, SMU assistant professor of communication arts, will keep everyone focused.

November's meeting at Water Street Seafood in University Park shopping center, one block south of I-30 on University Drive, was deemed a culinary and logistical success, so it's Water Street again. The board meets at 5:30 p.m., mingling (cash bar) is at 6:30, dinner at 7.

Four choices grace the menu: 8-ounce mesquite-grilled chicken breast, 4-ounce brandy mushroom trout filet, a pasta shrimp salad or shrimp-k-bob, each with a salad, rice pilaf, the ubiquitous vegetable of the day (we bet corn), fresh-baked bread and tea, soft drink or coffee.
